MAIN GOAL

To analyze and counteract the ways under which corruption assails women's human rights. We are women who, given the lack of values many of our countries suffer, and without pretending to be the sole representatives of ethical behavior, wish to contribute a different outlook and promote the culture of justice and lawfulness through our actions.

SPECIFIC GOAL

To draft a Program of Strategic Alliances with activities, effective mechanisms and tools to strengthen women's leadership towards their active participation in the local and international struggle against corruption.

ACTIVITIES

Panel presentations, testimonials, workshops, advocacy networking, cultural and social activities, strategy building to include a gender perspective in public policies against corruption and actively fight against the culture of impunity.

BACKGROUND

The first Conference of the WOMEN'S FORUM AGAINST CORRUPTION took place on September 22, 2000, in Buenos Aires, Argentina. Over 300 women attended and participated in 10 panels followed by debates. The subject was: *"Forms of corruption and how to prevent them in: government, mass-media, the practice of professions, workers unions, health, corporations, daily life (citizens' rights), justice, environmental issues. The final panel addressed "Women in decision-making propose public policies"*

The Forum's activities went on in November 2000, with a panel/debate on: *"How to prevent corruption in culture"* and on August 2001 with a debate on *"Education as a State policy in the last decade"*, at Museum Roca, Buenos Aires.

The first **GLOBAL FORUM OF WOMEN POLITICAL LEADERS "New Millenium, New Rules"** took place in Manila, Philippines, in January 17-19, 2000, as a Preparatory Forum for the United Nation's Beijing+5 Review. Politicians from all levels, young women, women from ethnic groups, academics and researchers, NGO activists, business leaders, professionals, religious and grassroot leaders participated in this program which built on their experiences and expertise. Its convener was Irene Santiago, President of The Institute for Women's Leadership, Manila, Philippines

VIRTUAL REVIEW PROBIDAD

Probidad is an initiative of El Salvador civil society that include local and regional, traditional and virtual components. It started on March 1994 to open a debate on Salvadorean corruption and to promote its exposition and sanction. In El Salvador, it is a network, a social control organization, a clearinghouse and a supplier of advice services on corruption and local anticorruption.
